The total number of sections of the school shall be restricted to 18 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school.

The number of students shall be restricted to the size of the room (0.08 X size of the room).

<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of sections of the school shall be restricted to 18 as per the number of sections reported during inspection, of which not more than 1/3rd sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of >500 ft dimension
2	During review, it is informed by the school that the new building block is under construction which will be used for secondary and senior secondary section of the school. Therefore, the school is directed to complete the construction work within 03 months with proper facilities and provision for CwSN and also obtain renewed safety certificates for the for entire school and submit the compliance.
3	The school is required to make (i) the separate reading space in the library for staff (ii) proper permanent signage on the cubicle indicating the floor number of the CwSN toilets within 03 months and submit the compliance
4	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance.
5	Failure to submit compliance on the above mentioned points within the prescribed time shall invite financial penalty against the school.
6	The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
7	The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school shall renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
